R2P at 10 Conference a Success

On the 26-27 February, members of the Centre travelled to Cambodia to celebrate and analyse the 10th anniversary of the Responsibility to Protect Doctrine at the R2P at 10 conference. The conference discussed the progress, challenges and opportunities for R2P in the Asia Pacific in the past decade, what has been learnt and where the region is looking to for the future.

R2P at 10 in their own words

Working with major players in the Asia Pacific region to understand their role in the Responsibility to Protect is one of the main areas of work for the AP R2P. Welcome to AP R2P Visitors

The Centre welcomes Dr. Ma Lourdes Veneración-Rallonza from Ateneo de Manila University to the Centre as one of the DFAT Australia Awards Fellows.

Dr Rallonza serves as a consultant to the Office of the Presidential Peace Process and on the implementation of the Philippine National Action Plan on WPS. Dr Rallonza's research as part of the Fellowship will focus on developing policy proposals on strengthening ASEAN mechanisms for the protection of women and girls. the UN Beijing Platform for Action and 15 years since the passing of Resolution 1325, the first resolution to stress the importance of women's equal and full participation in the prevention and resolution of conflicts, peace-building and peacekeeping.

A culture of excluding women from political and security structures amongst the member states of the Association of Southeast Asian Nations (ASEAN) is a barrier to mediating conflict and preventing sexual and gender based violence during conflict and disasters. Also to ensuring women's economic and social empowerment in post-conflict settings. Members of ASEAN have endorsed multiple commitments to prevent violence against women, but ASEAN has yet to adopt specific measures to implement the Women, Peace and Security agenda into its political-security policy framework.

The purpose of this Fellowship program is to deepen the knowledge and skills to advance the implementation of the WPS agenda. This will contribute to a regional shift from a culture of women's exclusion to a culture of gendered conflict prevention and societal resilience in Southeast Asia. The program will advance the priority development area of gender equality and the empowerment of women and girls through peer-to-peer and intra-regional knowledge exchange and policy dialogue on concrete measures to strengthen the protection and participation of women in governance, judicial and security institutions.


