


### Asia Pacific Centre for the Responsibility to Protect

It was his leadership that led to the inauguration of the Centre in 2008 and the signing of the first Agreement between the University of Queensland and AusAID in 2009. During the years when he has been at neighbouring Griffith University, Prof Bellamy continued to be involved in many aspects of the Centre's work by providing strategic advice, supervising PhDs, and leading a research program that has led to an impressive list of publications. Prof Bellamy is one of the international leading scholars in the field of international security, and the Centre is honoured to have his leadership.

This one-day workshop held on 20 August provided an opportunity for regional dialogue to identify ways of deepening action to prevent sexual violence in armed conflict and humanitarian disaster situations with the Women, Peace and Security agenda. <a href="Sara E. The Centre will host a major conference in Phnom Penh, Cambodia, on 26-27 February 2015, to mark the 10th Anniversary of the adoption of the Responsibility to Protect at the 2005 World Summit. The Centre is organising this event in partnership with the Global Centre for the Responsibility to Protect, the Cambodian Institute for Cooperation and Peace and the International Coalition for R2P.

#### Boko Haram and the Challenge of Security in Africa

This panel discussion on the ongoing crisis created by the Boko Haram rebel group in Nigeria was held on 12 August, and included speakers Tim Dunne, Nicole George, Joseph Hongoh, Charles Hunt, and Wisdom lyekekpolo, who discussed Nigeria's domestic response to the crisis, compared Boko Haram with other rebel groups in Africa such as Al Shabaab, the regional security dimensions, and the broader implications for the Women, Peace, and Security Agenda. #### Public Seminars on ASEAN and R2P in Phnom Penh. Cambodia

Noel M. Morada, Director of the Centre's Regional Diplomacy and Capacity Building program delivered two public lectures in Phnom Penh, Cambodia on 6 and 8 August, focusing on the role that Cambodia can play in promoting R2P in ASEAN. The first seminar was organized by the Cambodia Institute for Cooperation and Peace (CICP), and was attended by representatives from ASEAN, Australia, and European diplomatic missions, government officials, think tank researchers, and university students. The second seminar on the same topic was organized by the Department of International Studies, Institute for Foreign Languages, of the Royal University of Phnom Penh in cooperation with Pannassastra University of Cambodia, where some 60 students participated in the interactive workshop. These seminars were conducted as part of the Centre's efforts to support its Cambodian partners in building awareness and constituencies around the Responsibility to Protect concept.

# Preventing Mass Atrocities: The Role of Parliamentarians and Civil Society Groups in Indonesia

The Centre, in partnership with the Human Rights Working Group of Indonesia, organised a two-day seminar on mass atrocities prevention at Novotel Bogor on 5-6 June 2014. Noel M. Morada delivered lectures on R2P and the importance of mass atrocities prevention, and helped facilitate the discussions among participants.

The meeting focused on the role of parliamentarians and civil society groups in promoting the Responsibility to Protect (R2P) principle by identifying current issues, opportunities, and challenges in preventing mass atrocity crimes in Indonesia. The 15 participants in the seminar came from government, human rights organisations, legislative staff, the national human rights commission, think tanks, and NGOs working in peace and conflict. Participants were provided with copies of the R2P Toolkit and the Inter-Parliamentary Union's (IPU) resolution on R2P, which were translated into Bahasa Indonesia. Read More >

#### **UN Association of Australia Emerging Scholars Seminars**

Organised by the UN Association of Australia in association with the APR2P Centre, the Queensland Emerging Scholars Program provided a space for interested students to discuss and debate ideas and challenges in their current research with senior UN academics, practitioners and representatives of relevant government agencies. Two sessions have been held in May and August 2014.

### **How Peace Operations Work: Analysing Local Legitimacy**

UNSW Lecturer Jeni Whalan presented the findings from her recent book<u>How Peace Operations Work</u> in a seminar held on 22 May at the University of Queensland. Dr Whalan focuses on the significance of local support for the success of peace operations, and discussed practical policy recommendations to make peace operations both more legitimate and more effective.

## What Happens When We Respond to Mass Atrocities? Insights from Africa

Senior Lecturer in International Human Rights at the University of Glasgow, Dr Kurt Mills, visited the Centre for R2P between March and May this year to continue his research into the relationship between the responsibility to protect and the International Criminal Court. In a seminar co-hosted by the Centre for R2P and the UQ School of Political Science and International Studies on 9 May, Dr Mills discussed the perplexing conundrums and unintended consequences evident in the implementation of the three sets of norms used to deal with situations of mass atrocities (humanitarianism, international criminal justice, and the use of military force) in sub-Saharan Africa.

### **Education and Training Highlights**

International Diplomacy – A professional training course for African diplomats

R2P Centre Researcher Dr Charles Hunt led 28 mid-career diplomats from across Africa in a trip to Canberra this August to meet with counterparts in the Department of Foreign Affairs and Trade (DFAT). This trip is part of a professional training course funded by the Australian government under the Australia Awards fellowship scheme. The 5-week program is a partnership between the Centre, UQ International Development, and the University of Pretoria. The course addresses the theory and practice of diplomacy in a globalising world, and includes modules on diplomatic rules and resources, the international system, new security challenges, development and conflict mediation.

#### New Undergraduate Course in Human Security and R2P

Phil Orchard is also teaching a new course in Semester 2, 2014, in Human Security and the Responsibility to Protect at the 2<sup>nd</sup> year undergraduate level. The course examines how the two concepts have changed international security in the past two decades, and includes an intensive simulation examining the UN Security Council's response to a fictional mass atrocities situation.
